- 1. Tender papers in complete shape must be accompanied with attested copies of valid registration certificate, PAN Card, GST certificate, required EMD pledged in favour of DPP, OUAT, BBSR along with original money receipt of tender paper cost. The successful bidder shall deposit the ISD amount @1% of his quoted amount at the time of agreement. Tender papers without required EMD as detailed above in column (4) will be summarily rejected.
- 2. Additional performance security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Terms Deposit Receipt pledged in favour of DPP, OUAT, Bhubaneswar from any Nationalized/Schedules bank in India within 7(Seven) days of issue of letter of acceptance by the DPP, OUAT, Bhubaneswar to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money deposit/bid security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.

The details of tender paper will be sold in the office of the under signed from 03.03.2020 to 17.03.2020 (Up to 05:30 P.M) and it will received by the office on date 18.03.2020 (Up to 04:30 P.M) and will open on 5 P.M on the same day in presence of the tenders and their authorized representives.
- 4. Each tender shall be accompanied by original affidavit as per "Schedule-F" regarding authentication of documents by the tenderer failing which tender will be liable for rejection.
- 5. These are time-bound works and are to be completed within the stipulated period. The respective bidder are advised to study the scope of work and survey the site for constrains if any and assess their bid capacity and capability before submitting their tenders.
