**NOTICE FOR PHASE 4 SEAT ALLOCATION & COUNSELLING
FOR UG ADMISSION – 2020-21**

1. **FOR CANDIDATES WHOSE DOCUMENT VERIFICATION COMPLETED BETWEEN 18TH-20TH & 29TH-30TH DECEMBER, 2020 AND WHO HAVE OPTED FOR UPGRADATION**
 - A) Login to check up-gradation status on 04.01.2021 (Date of phase 4 seat allocation).
 - A) If seat upgraded to higher choice of seat in the list of choices, then download provisional seat allocation letter and **pay the differential fee (if any) as mentioned in the letter through cash at bank (SBI) through SB collect chalan or payment through net banking from 04.01.2021 to 05.01.2021 (4 pm). Without differential fee payment (if any), the allocated seat will be forfeited even if document verification has been completed. Payment procedure is available in provisional seat allocation letter.**
 - B) No Up-gradation/quit option is available in phase 4 / final round seat allocation & counseling. The seat will be auto locked. No need of document verification. After differential fee payment if any, you can download admission letter.
 - C) If no up gradation of seat in this phase seat allocation, then download the admission letter.
2. **FOR CANDIDATES WHO ARE FRESHLY ALLOCATED SEATS IN PHASE 4/FINAL ROUND SEAT ALLOCATION AND COUNSELING**
 - B) Download the provisional seat allocation letter.
 - C) No up-gradation/lock or quit option is available in this phase of seat allocation & counseling. The allotted seat is auto locked and final.
 - D) **You must pay the admission fee as mentioned in the provisional seat allocation letter through cash at bank (SBI) through SB collect challan or payment through net banking from 04.01.2021 to 05.01.2021 (4 pm), failing which the allocated seat will be forfeited. Payment procedure is available in provisional seat allocation letter.**
 - E) After completing the above process mentioned at 'C' download the intimation letter to attend the document verification and admission between 07.01.2021 to 08.01.2021 (between 10 a. m to 4 p. m) at centre mentioned in the intimation letter.
 - F) You will forfeit the seat if you don't attend the document verification and admission on dates mentioned above.
