1. Tenders in complete shape must be accompanied with attested copies of valid registration certificate, PAN Card, GST certificate, alongwith original money receipt/T.P. Cost (Non- refundable as column No. 6) in shape of B.D. drawn in favour of D.P.P.,OUAT,BBSR towards purchase of Tender paper & required EMD in the prescribed form of Government as per OPWD code. The successful bidder shall deposit the ISD amount @ 1% of his quoted amount at the time of agreement. Tender without required EMD as detailed above in column (4) will be summarily rejected. The EMD relaxation for SC/ST and Physical handicapped contractors is applicable as per rules in force.
2. Additional performance security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Term Deposit Receipt pledged in favour of DPP, OUAT, Bhubaneswar from any Nationalized/schedules bank in India within 7(Seven) days of issue of letter of acceptance by the DPP, OUAT, Bhubaneswar to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/bid security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.
3. The details of tender paper can be had from the office of the undersigned during office hours & the details of above tender documents are also available on website www.ouat.nic.in from 03.07.2019 to 18.07.2019 (upto 11.30 A.M) Intending tenderers can also download the tender documents from the above web site and submit alongwith each tender DD as per the "column 6" of the tender notice in a separate envelope super scribed as "Cost of tender documents down loaded from the website" and it will be received by the office up to 1.30 P.M. on dt 18.07.2019 and will be opened at 3.30 P.M. on the same day in the presence of the tenderers or their authorized representatives

4. Each tender shall be accompanied by original affidavit as per "Schedule-F" regarding authentication of documents by the tenderer failing which tender will be liable for rejection.
5. These are time-bound works and are to be completed within the stipulated period. The respective bidders are advised to study the scope of work and survey the site for constraints if any and assess their bid capacity and capability before submitting their tenders.
6. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
